



Position: **Regional Field Coordinator (East Michigan)**

Overview of Responsibilities:

The Regional Field Coordinator is responsible for implementation of all AFL-CIO activities and programs to advance labor's political goals in the eastern region of Michigan (primarily Flint, the Tri Cities, and the Thumb). These goals and activities include public meetings and hearings, phone banks, offices and canvasses (when applicable), release staff and volunteer management, reporting, and other duties as assigned. The ideal applicant will be a resident of Genesee County or Greater Lansing, but other interested parties are encouraged to apply.

The Regional Field Coordinator will report regularly to the Campaigns Director and/or Field Director of the Michigan AFL-CIO. The Regional Field Coordinator's work plan will be determined by the Michigan AFL-CIO.

Responsibilities/Duties:

The Regional Field Coordinator at the Michigan AFL-CIO will be responsible for:

- Establishing, Maintaining, and Growing a Labor Activist Network.
 - The Regional Field Coordinator manages and regularly updates the database(s) for outreach to unions, community allies, and individual volunteers, and works to expand it. They build relationships with local labor organizations and union leaders, then recruit and coordinate volunteers through those networks for a variety of events.
- Planning, Managing, and Executing Labor and Voter Contact Events.
 - The Michigan AFL-CIO is building a significant voter contact program wherein the Regional Field Coordinator will play a significant role every step of the way. The Regional Field Coordinator will be responsible for recruiting for, training of participants, and overseeing all direct voter contact events within their region.
- Overseeing Electoral Work in Region.

- The Regional Field Coordinator serves as the point person for the Michigan AFL-CIO within their region on all electoral work in addition to acting as a liaison between local labor councils and the AFL-CIO
- Other duties as assigned.

Qualifications:

- Previous campaign experience is required. Previous experience working in, with, or for the labor movement is highly desired.
- A commitment to the labor movement and an understanding of labor's goals. They must be able to advance projects and programs that convey these goals by working with union leaders, members, and community activists in high-pressure situations and under difficult deadlines.
- An understanding to direct all activities while following the campaign priorities and field plan of the Michigan AFL-CIO.
- Excellent verbal communication skills are essential, including the ability to interact successfully with individuals from diverse ethnic, racial, age, gender, educational, occupational, and socio-economic backgrounds.
- The popular / labor education skills necessary to design and lead workshops aimed at leadership and volunteer development.
- Required written communication skills include the ability to produce newsletters, leaflets, basic phone and walk scripts, work plans, and project reports.
- Computer skills are required, including knowledge and extensive use of e-mail, Google Drive, Zoom, Google Meet, MS Word, the Internet, Excel, LAN/VAN, and social media, with a working knowledge of PowerPoint.
- Strong people and organizational skills are required to carry out all priorities of the campaign.
- A valid driver's license, continuous use of a reliable vehicle, automobile liability insurance, and be willing to travel throughout the region on a regular basis.
- Occasional travel to other parts of the state and/or out-of-state may be necessary. Overnight travel will be infrequent but may be required.
- Long work hours, some holiday work, and frequent participation in evening and weekend activities are required, and attendance at early morning calls or events will be expected
