POSITION DESCRIPTION: MEDIA PRODUCTION SPECIALIST

Introduction: The Michigan AFL-CIO is a non-profit federation of labor unions representing over 1 million working Michiganders and is seeking to hire an experienced media production specialist. This position will report to the Communications Director of the Michigan AFL-CIO and work in conjunction with the Michigan AFL-CIO and its various departments and divisions.

Duties and Responsibilities:

- Spearhead media and video production operations for the Michigan AFL-CIO and its nonprofit divisions including the Workforce Development Institute, Michigan AFL-CIO Advocates, and the Labor Foundation.
- Conceptualize, produce, and edit striking video content that advances our programming and messages.
- Collaborate with the campaigns department and Digital Director to produce and deliver digital video ads for the 2024 cycle.
- Under the direction of the Chief of Staff and Communications Director, produce longform video content for a variety of large projects and events.
- Stay informed and updated on the latest trends in video production and content-sharing platforms including but not limited to Meta (Facebook and Instagram), Twitter, Youtube, TikTok.
- Collaborate with Michigan AFL-CIO Advocates to support our legislative agenda with engaging video content for paid advertising and social media.
- Collaborate with the Workforce Development Institute to shoot and edit video content around current and emerging programs, events, and marketing initiatives.
- Provide video support at Michigan AFL-CIO and affiliated events including but not limited to media events and press conferences, conventions, rallies, etc.
- Provide video production services to affiliated labor unions to support their media goals.
- Other duties as assigned.

Qualifications:

- A bachelor's degree is required in media production, public relations, marketing, journalism, English, creative writing, public policy, or a closely related field.
- 5+ years (or 2+ cycles) of experience in video and media editing and production.
- High proficiency in editing software such as Adobe Premiere / Final Cut is required.

- High proficiency and technical knowledge of production equipment, audio, video, lighting, etc. is required.
- Wealth of experience producing and editing a range of video content including digital ads, tocamera interviews, longer-form narrative videos, and/or documentaries.
- Experience in branding and marketing is a plus.
- Familiarity with and commitment to the labor movement and an understanding of labor's goals is required.
- Strong time management and organizational skills are required, including a demonstrated ability to independently manage and prioritize multiple tasks and projects in high-pressure situations and under difficult deadlines.
- Excellent communication skills are required, including the ability to quickly synthesize and distill complex information into concise, impactful public-facing video content; the ability to communicate with and on behalf of individuals from diverse ethnic, racial, age, gender, educational, occupational, and socio-economic backgrounds; and the skills necessary to produce video content effectively in a fast-paced, high-pressure environment with short deadlines.
- Computer skills are required, including knowledge and extensive use of e-mail, Zoom, Teams, Google Meet, Microsoft Office, and Google Drive.
- A valid driver's license, continuous use of a reliable vehicle, automobile liability insurance, and willingness to travel.
- Occasional travel to other parts of the state and/or out-of-state may be necessary. Overnight travel will be infrequent but may be required.
- Long work hours, some holiday work, and frequent participation in evening and weekend activities are required, and attendance at early morning calls or events will be expected.
